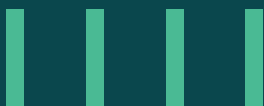

# Introduction

This Investor Guide aims to provide a reference to investors in the defense sector to learn about the general procedures for obtaining Establishment Permits and Licenses (subject to GAMI approval). This Guide ensures a clear methodology, within an organizational framework, for all stakeholders of establishments and those operating in this field. This Guide would be incomplete without referring to the Regulations on Organizing Military Industrial Activities Practice in the Kingdom issued by the GAMI Board of Directors' Resolution No. (C/2/6) dated 1440/11/14H (corresponding to 2019/07/18G) based on GAMI Regulations issued by the Council of Ministers' Resolution No. (210) dated 1440/04/25H (corresponding to 2019/01/01G).

## Definitions

---

### GAMI or The Authority:

General Authority for Military Industries.

### Regulations:

The regulations for organizing defense sector practices in the Kingdom.

### Controlling Persons:

Any members of applying entity including owners, members of the board of directors, CEO and anyone administratively reporting to the CEO.

### Investor Guide:

A document including all information, procedures, controls, and steps needed by the investor to obtain Establishment Permits / Licenses.

### Trader:

Licensed entity for trading military articles.

### Coding Number (ISIC):

The national classification for economic activities.



## Definitions

---

### **Applicant:**

---

Entity that applies for an Establishment Permit or License issued by GAMI.

### **Host:**

---

Economic Cities and Special Zones Authority (ECZA), Royal Commission for Jubail and Yanbu (RCJY), General Authority for Civil Aviation (GACA), Saudi Authority for Industrial Cities and Technology Zones (MODON). Saudi Ports Authority (MAWANI), and areas within the scope of sites designated for industrial cities, in addition to military establishments and bases.

### **The Military Industries Unified Portal**

---

A document including all information, procedures, controls, and steps needed by the investor to obtain Establishment Permits / Licenses.

### **Investor Journey:**

---

Steps taken by the investor, starting from applying for the permit/license until the issuance thereof.

### **Industrial License:**

---

A license issued by the Ministry of Industry and Mineral Resources (MIM) upon fulfilling GAMI's conditions and requirements.

### **Authorized Person**

---

The person who is responsible and authorized by the facility. To manage the account in The Military Industries Unified Portal.

## Types of Military Licenses



### Military Manufacturing



### Military Services Provision



### Trading of Military Articles

#### Establishment Permit:

A Permit issued by GAMI to an Applicant seeking to manufacture military equipment. The License authorizes the Applicant to commence with the procedures relating to the Establishment's site, and obtain approvals from relevant entities, in preparation for issuing a Military Manufacturing License.

#### Establishment Permit:

A Permit issued by GAMI to an Applicant seeking to provide military services. The License authorizes the Applicant to commence with the procedures relating to the Establishment's site, and obtain approvals from relevant entities, in preparation for issuing a Military Services License.

#### Licenses

Licenses issued by GAMI authorizing the Applicant to trade military equipment in the Kingdom. The scope of the License comprises selling, renting, presenting or marketing to the Kingdom's defense and security entities, as well as entities licensed by GAMI. This License also authorizes those defense and security entities to test or commission such equipment.

#### Licenses

##### Manufacturing:

Licenses issued by GAMI authorizing the licensee to practice the activities of manufacturing and assembling military equipment.

#### Licenses

##### Provision of Services:

Licenses issued by GAMI authorizing the Applicant to provide military services in the field of repair, maintenance, overhaul, technical support, and providing technical jobs. It also includes improvement, operation, repair, maintenance and providing any person with any technological or technical information subject to the provisions of the regulations.

##### Technical Support Services:

Licenses issued by GAMI authorizing the Applicant to provide technical support activities that depends on human resources and must be practiced within military bases.



## General Conditions and Requirements



### General Conditions

- 1 The Applicant shall maintain a Commercial Registration, in which the business activities under the Foreign Investment Law, or those licensed by GAMI, are specified.
- 2 Foreign Applicants must hold a legal status in the Kingdom in one of the following legal forms:
  - Limited Liability Company
  - Joint Stock Company
- 3 All founders of the Applicant party must be free of criminal offence, as well as any disciplinary decision to be dismissed from military service, unless rehabilitated.



### General Requirements

- 1 The Applicant must comply with the Regulations of Military Industries, and all relevant laws and regulations.
- 2 The Applicant must obtain the Security and Safety Certificate before being awarded the operational License (for Establishment Permits).
- 3 The Applicant must provide the Authority with any updates to the status of the documents submitted to GAMI.

## Register an authorized person

1	Go to the Military Industries Unified Portal from GAMI's website.
2	<p>Log in to the authorized person page where the following details must be filled:</p> <ul style="list-style-type: none"> <li>• Authorized person details.</li> <li>• The commercial registration number of the entity.</li> <li>• Download the form of the letter of authorization, fill it out and certify it electronically from Riyadh Chamber, and then re-upload it on the same page.</li> <li>• For foreign investors, Upload the incorporation document and investment licenses.</li> <li>• Upload a personal picture of the authorized person.</li> <li>• Send the request.</li> </ul>
3	The authorization request is reviewed by GAMI (two working days).
4	<ul style="list-style-type: none"> <li>• Receive an email from GAMI Accepting / rejecting the request of the authorized person.</li> <li>• If the authorization request is approved, enter the link attached to the email to complete the authorization approval information and the login to the platform details.</li> <li>• In case of rejecting the authorized person request, the request will be sent back to repeat the previous steps with the amendment of the note added by GAMI.</li> </ul>
5	Create a password, complete the entity's information, and access the authorized person page.

✦ The entity can authorize more than one person.

✦ The entity shall be selected through the delegation page, and then you can apply for the available services.

**Registration and Choosing  
the Desired Activity**

Registration on the Military Industries Unified Portal is required, and a valid Commercial Registration must specify the business activities in Military Manufacturing.



**Filling out the  
required data**

- 01 Fill out the Applicant's required data.
- 02 Fill out the data of the CEO, the Authorized Person.
- 03 Add all Controlling Parties.
- 04 Fill out Initial information about manufacturing and products shall be filled out in details.
- 05 Attach the required documents: (Commercial Registration, Hierarchy Chart, Article of Association).
- 06 Send Application.



**GAMI Reviews the  
Application**

The Application is reviewed by GAMI, and the Applicant is informed of further steps to be completed (if any).



**Fees  
Payment**

The fees should be paid through SADAD system.



**Issuance of the  
Establishment Permit**

The Establishment Permit shall be issued in order to allow the Applicant to commence with procedures relating to establishing the production site, without commencing with Manufacturing activities until a Military License is obtained.

**Applying for a Military  
Manufacturing License**

- 01 The Application for a Military Manufacturing License shall be submitted through the Military Industries Unified Portal.
- 02 The Applicant's information and the actual investment size must be verified.
- 03 Authorized Person and Controlling Parties information shall be updated in case of a change therein.  
Attach the required documents:
  - The Security and Safety Certificate/ Letter from the High Commission for Industrial Security - (HCIS) after completing construction works.
- 04 Social Insurance record.
- 05 The actual information about manufacturing and products shall be filled out in details.



**Reviewing the Application and  
Conducting a Field Inspection**

The Application shall be reviewed by GAMI. If the Application is deemed incomplete, a notice will be sent to the Applicant accordingly. A field visit shall be conducted to confirm establishment's compliance with requirements for that License.



**Fees  
Payment**

The fees should be paid through SADAD system.



**Military License  
Issuance**

The Military Manufacturing License shall be issued, and the Applicant shall be authorized to commence with the Activity.

## Applying for a Military Services Establishment Permit

Registration on the Military Industries Unified Portal is required, and the Commercial Registration must be valid and specify the relevant business activities.



**Filling out the required  
data**

- 01 Fill out the Applicant's required data.
- 02 Fill out the data of the CEO, the Authorized Person.
- 03 Add the Controlling Parties.
- 04 List the names and descriptions the services to be provided.
- 05 In the case of providing technical support services, initial information about the scope of technical support for each thereof shall be specified in detail.
- 06 Attach the required documents.  
(Commercial Registration, Hierarchy Chart, Article of Association)
- 07 Send Application.

- 01 The Application for a Military Services Provision License must be submitted through the Military Industries Unified Portal.
- 02 The actual information of the technical support services provision scope based on the contract concluded with the beneficiary.
- 03 A copy of the valid contract concluded with the beneficiary entity shall be attached.
- 04 The social insurance record shall be attached.
- 05 Send the application.



**Reviewing the application and  
contract**

The Application shall be reviewed by GAMI. If the Application is deemed incomplete, a notice will be sent to the Applicant accordingly.

The fees should be paid through SADAD system.



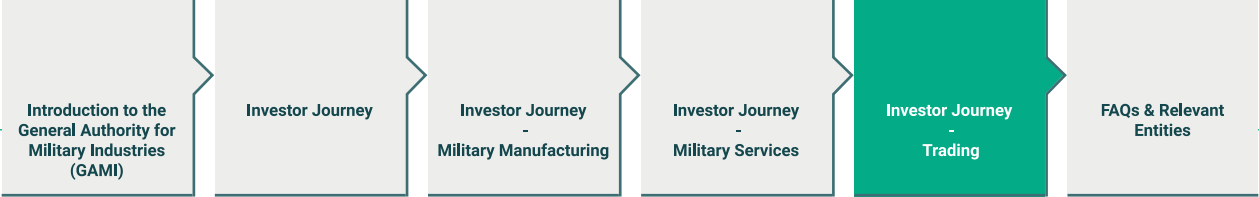

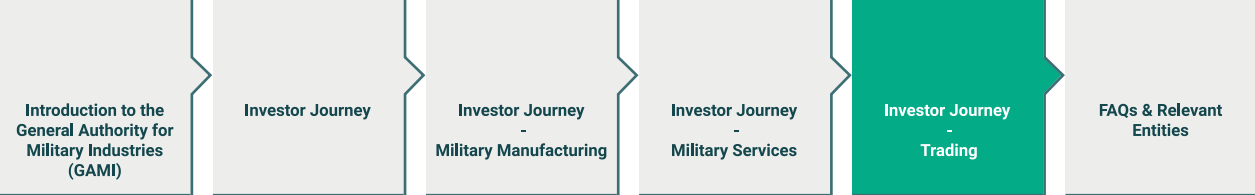

## Applying for the Military Trading License



### Ensure the Registration of an Authorized Person by the Company

See Slide 16



### Registration and Choosing the Desired Activity

Registration on the Military Industries Unified Portal is required, and the valid commercial registration must identify the business activities of military products supply.



### Applying for the Military Trading License

- 01 fill out the applicants, contributors , owners informations and ensure to attach the following documents:
  - The incorporation contract for all the registerd companies under the owner of applicant's request.
  - Identify all the owners individuals
- 02 Add all the controlling parties information.
- 03 A detailed description of products to be supplied shall be mentioned, and attach the required documents including the authorization letter issued by the manufacturer and should state the following:
  - The letter shall state the appointment of the authorized party as a certified agent or distributor in KSA.
  - Products to be supplied
  - The authorization expiry date.
  - A stamp issued by the KSA embassy in the manufacturers country or APOSTILLE Certificate.
- 04 Attach the required documents.
- 05 Send the Application through the Military Industries Unified Portal.



### Reviewing the Application

The Application shall be reviewed by GAMI. If the Application is deemed incomplete, a notice will be sent to the Applicant accordingly.



### Fees Payment

The fees should be paid through SADAD system.



### Military License Issuance

The Military Trading License shall be issued, and the Applicant shall be authorized to commence with the Activity.

## FAQs (3/1)

### What are the Regulations on Organizing Military Industrial Activities Practice in the Kingdom?

The Regulations on Organizing Military Industrial Activities Practice in the Kingdom interprets the work controls in the military industrial sector and develops the provisions thereof.

### Who are the Controlling Persons / Parties?

They include the Applicant's founders, owners, partners, board members, and CEO, in addition to persons administratively reporting to the CEO.

### Can Licenses be amended?

Yes, the license can be amended within the limits of business activities related thereto. This includes amending business activities or license scope.

### What is the purpose of obtaining a License?

The main purpose of obtaining a license is to regulate work within the defense sector by controls that govern it according to the laws with the aim to develop the sector and promote competition.

### What is the purpose of issuing an Establishment Permit?

To allow the applicant to commence the procedures related to the establishment's site and approvals from relevant entities, in preparation for issuing the military manufacturing licenses, or military services provision licenses.

### What are the fees for reviewing an Application?

The fee for reviewing an Application is a non-refundable amount, which is paid for reviewing the Application for issuing an Establishment Permit or License.



## FAQs (3/2)

### What Fees are associated with issuance of a License?

It is an amount paid for obtaining the License.

### Can a foreign investor obtain a License?

Yes, foreign investors can obtain Licenses after fulfilling the license requirements and conditions.

### How can I determine the status of my Application for a License?

Through The Military Industries Unified Portal, or any of the Channels at your disposal (see last page of this Guide).

### Does GAMI issue licenses for manufacturing small weapons?

Small weapons such as air-guns, hunting weapons and their equipment, spare parts and ammunition are not within the scope of GAMI.

### Is it allowed to practice the activity outside industrial cities?

Any activity subject to GAMI's regulations shall be within the scope of industrial cities and/or areas within the scope of sites allocated for industrial cities, or military bases and establishments.

### Is there a license for an activity that serves both the military and commercial sectors?

GAMI is responsible for issuing the licenses of military activities only.

### Does GAMI issue Licenses for Military sewing shops?

The Regulations on Organizing Military Industrial Activities Practice in the Kingdom interprets the work controls in the military industrial sector and develops the provisions thereof.

### How can the account be transferred to the name of the new Authorized Person, noting that the Authorized Person has been changed?

### How can the data in the National Military Industries Portal be amended after the initial save?

The main purpose of obtaining a license is to regulate work within the defense sector by controls that govern it according to the laws with the aim to develop the sector and promote competition.

### Are Commercial Registrations and Applications logged on the National Military Industries portal before or after military activities are added to the Commercial Register?

Subject to GAMI's supervision, the military activities are added before logging the Commercial Registrations and Applications, thereby making it possible to register and apply on the Platform.
